Introduction to the Critically Infused Social Work Website

In the midst of the COVID-19 pandemic, many social workers, social work students and other service providers are overwhelmingly restricted to both working online and accessing digital content to learn, research and even apply social work in practice. For this reason, we decided a fitting format for a hands-on critical social work (CSW) practice resource would be through the development of a website. Our website, Critically Infused Social Work, serves as a resource for social workers to learn about and engage with both critical and conventional approaches for developing an infused CSW practice. A unique contribution of this website is that, in addition to descriptions of both critical and conventional social work approaches, it offers suggestions on how to “infuse” conventional approaches with critical social science theories. Ultimately, the website hopes to serve as a resource for social workers who would like to develop an infused CSW praxis.

What is An Infused Approach?

Critical theories often do not fit neatly into conventional approaches. We have used the term “infused approach” to acknowledge that the application of a critical theory to a conventional social work approach can often modify some of the fundamental components of the conventional approach. Furthermore, the critical theory itself can change when asked to take an applied form.
